COUNCIL COMMITS £5M TO HELP OWNERS BRING EMPTY PROPERTIES BACK INTO USE

Kent County Council has allocated a £5 million capital fund to support the No Use Empty campaign. The funding is a major boost for the initiative which is helping to bring empty properties back into use in East Kent.

The campaign is raising awareness of the problem and helping to make owners aware of the positive options available to them to bring their properties back into use. There is free help and advice on offer to landlords, developers and owners of empty properties.

DOVER DISTRICT COUNCIL HELPSTURN DERELICT HOTEL INTO HOUSING

Dover District Council has helped transform a dilapidated hotel in Dover town centre into new accommodation, providing 28 one and two bedroom flats (see 'after' photo on front page). Having remained derelict for some years, the Metropole Hotel was to be given a new lease of life after being purchased by new owners. However, they were unable to meet the necessary costs required to transform the hotel into new flats.

A significant contribution was made by the council to help meet the renovation costs and the first tenants are expected to move in later this year. The new accommodation, which will be managed by a local Housing Association, is an excellent example of how intervention from a local authority can help turn an empty building going to waste, into new, much needed housing for the local community.



The Metropole in Dover was recently renovated following financial support from Dover District Council. The former hotel had been out of use for over 15 years but has now been converted into 28, one and two bedroom flats.

LOAN SCHEME IN PLACE FOR PROPERTY OWNERS

Landlords, developers and owners of empty properties can now apply to Kent County Council for a loan to help with funding renovation and refurbishment works to bring empty properties back onto the market for rental or sale.

This will be a major boost to help with costly refurbishment and improvement projects and it presents new options to empty property owners, who may need financial help, from new roofing works to replacing rotten timbers and windows.

This is the first scheme of its kind to be launched by a County Council.

The participating District Council will 'sponsor' applications for renovation loans to property owners. This will allow landlords and owners of empty properties to discuss their proposals with the empty property officers at an early stage and get good impartial advice on how best to bring their empty properties back into use.

Property owners will need to ensure that relevant planning permissions and building regulation approvals are already in place. They will also need to provide timescales for the completion of the schemes.

BRINGING PROPERTIES BACK TO LIFE

Vacant and dilapidated properties can act as a disincentive to attracting new investment in an area. To tackle this problem, a further fund has been set up from the capital funding money available. The Kent Empty Property Acquisition Scheme will enable KCC to buy empty houses in regeneration areas, to help bring new investment into key neighbourhoods.

This is a big opportunity

for Kent County Council, in partnership with the participating District Councils, to target specific empty properties as part of wider regeneration activities, such as Margate Old Town, Dover Pride, Swale Forward and The Creative Foundation in Shepway.

Once Kent County Council has purchased an empty property it will be renovated and sold on the open market. The money made from any sale of a property would then be returned to the capital fund, to ensure the continuation of this process for years to come.

The ability for Kent County Council to purchase these types of properties directly is a huge community benefit and demonstrates a real commitment towards housing regeneration activities and sustainable growth in housing and the community.

This fund will help support already existing and new regeneration plans, and contribute to a positive future for a vibrant and growing community.



EMPTY PROPERTY STERCLASS

The No Use Empty campaign hosted a special seminar to help Empty Property Officers from across Kent increase their knowledge and understanding of the latest legislation, which can help bring empty properties back into use.

The one day seminar was attended by 37 empty property practitioners from all Kent District Councils. The day included presentations from a series of keynote speakers from across the country, who were able to deliver a national perspective on key

issues facing the sector.

As part of the £5 million capital fund, a Partnership Fund has been created which will provide additional resources for the four Districts to maintain proactive work in encouraging owners to bring their empty properties back into use.

This could include assisting
District Councils with enforcement
procedures to embark on a
compulsory purchase of a
property or an enforced sale.
Such actions are always viewed a
measure of last resort, and not a
plan of action that will be taken
lightly by District Councils.

MEET THE TEAM

Each newsletter will feature a profile of a member of the No Use Empty team. For the autumn issue, lain Cobby, Empty Homes Officer at Shepway District Council, takes the hot seat and talks us through a typical day at work ...

I'm in the office before 9.00am and spend the first part of the morning responding to e-mails, being busy on the telephone speaking to other officers, and updating my computer of yesterday's events.

I travel all over Shepway and carry out checks on the empty properties I am working on. This involves travelling to the farthest points of the district, Dungeness, Lydd and Brookland, however the majority of my work is centred on Folkestone.

I drive past a site where they are demolishing two buildings that have been empty for years, to make way for a block of nine flats. Great news! That's empty home work for you. Seeds are sown to reap a harvest for the future. Nothing is quick, you just have to bide your time and be patient.

After a quick sandwich for lunch, I take a call from a lady who owns an empty property in Hythe. I have received several complaints from neighbours over the condition of this 1960s semi and wrote to her some time ago to ask what her intentions were for the property, which was in need of some minor repair. She was calling to inform

me that the repairs had now been carried out, and because of my intervention, she was now in the process of selling the property.

What a result, the lady gets a fair price for her property and has money to put into another house for her son, the neighbours get new owners who will restore the house to its former glory and the price of property in the area increases. Furthermore, everyone gets a neighbourhood without the possibility of vandalism or a haven for drug abuse.

The life of an empty property officer can be a frustrating one. You need to be tenacious, yet patient, but ultimately it is a very important and rewarding job. I set off home satisfied with my day's work, and wondering what new challenges tomorrow will bring.
